### EQUIPMENT MECHANIC II

#### DEFINITION

To lead and participate in performing minor and major mechanical repairs to automotive and other power driven equipment.

The work assigned to the class involves journey level automotive maintenance duties and lead responsibility in the City's equipment maintenance program. The work requires the ability to determine maintenance and repair requirements on a wide variety of automotive and mechanical equipment, to obtain needed parts and supplies, to establish priorities and schedule maintenance and repair work.

#### SUPERVISION RECEIVED AND EXERCISED

Receives general supervision from the Public Works Superintendent.

EXAMPLES OF DUTIES - Duties may include, but are not limited to, the following:

Provide lead supervision and personally participate in performing a wide variety of maintenance and repair on City automotive and mechanical equipment.

Assign work and to assist subordinate personnel.

Maintain work time and material records.

Train and assist subordinate personnel in the performance of the more difficult maintenance and repair work.

Inspect, diagnose and locate mechanical and electrical malfunctions and failures on City automobiles, trucks, fire apparatus and a variety of large and small maintenance and construction equipment.

Overhaul, repair, and adjust engines, transmissions, differentials and clutches; tune engines; replace or repair faulty parts including wheel bearings, clutches, oil seals, shock absorbers, exhaust systems, steering mechanisms, hydraulic systems, pumps and related parts and equipment.

Repair and install such components as generators, distributors, relays, lights, switches and radio communications equipment.

Perform a variety of other light and heavy maintenance work involving equipment, vehicles, and the maintenance garage.

Perform related duties as assigned.

QUALIFICATIONS

Knowledge of:

Tools, equipment, and procedures used in the overhaul, repair, and adjustment of gas and diesel-powered equipment.

Operation and care of internal combustion engines.

Use of automotive shop tools, equipment, and methods used in welding.

Safe work practices.

Ability to:

Inspect gas and diesel-powered equipment to locate difficulties and estimate the cost and time of repairs.

Perform minor and major mechanical work on mechanical equipment.

Use a variety of tools and equipment with skill.

Understand and carry out oral and written directions.

Establish and maintain cooperative relationships with those contacted in the course of work.

Establish work priorities.

Purchase and maintain a parts and supplies inventory.

Prepare and maintain shop and repair records.

Supervise, train and evaluate assigned staff.

EXPERIENCE AND TRAINING

Any combination equivalent to the experience and education that could likely provide the required knowledge and abilities would be qualifying.

Experience: Three years of experience performing automotive maintenance and repair work.

Training: Specialized training in the maintenance and repair of gas and diesel-powered equipment.

License & Certificates:

Necessary special requirement is possession of an appropriate California driver's license.
